

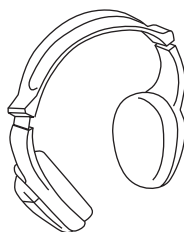

Single Source Mobile Wireless Headphone

• User's Manual

Please read this manual to maximize your enjoyment of the outstanding capabilities of this equipment. Retain this manual for future reference.



INTRODUCTION

CONGRATULATIONS on your purchase of the state-of-the-art, Single Source Mobile Wireless Headphone System. This system frees you from the tangle of headphone wires and lets you enjoy movies, video games or T.V. without the tangle of cables around you. To ensure the best performance of your system, please read this manual carefully.

SPECIAL FEATURES

- E.B.D. (Extended Bass Driver)
 - Automatic Level Control prevents input signal overloading.
 - Uses high frequency infrared light to assure a clean signal for clear reception.
 - Easy-fit, adjustable headband
 - For use with Alpine Mobile Overhead Monitor
 - Automatic Power OFF
- After a few minutes without a signal source, the power to the headphones will automatically turn itself OFF.

EXPLANATION OF CONTROLS (fig.1)

Headphone Receivers

- 1) INFRARED SENSORS - Receive signal from the transmitter
- 2) BATTERY COVER
- 3) VOLUME CONTROL
- 4) POWER SWITCH
- 5) POWER INDICATOR LED

BATTERY INSTALLATION (fig. 2)

- 1) Place two AAA batteries into the battery compartment of the Headphone(s), making sure that the battery polarity is correct.

NOTE:

This single source headphone, SHS-N101, is not compatible with the dual source system, SHS-N251.

OPERATION

Please Read Carefully to Prevent Damage to the Headphones or your Ears:

WARNING: Before turning on the power, remove headphones and turn the volume down as low as possible.

- 1) Be sure batteries are properly installed in the headphones
 - 2) Turn the headphone volume completely down before placing it on your ears and turning on the power.
- Turn on the headphone power and adjust the headphone volume to a comfortable level (You can increase the audio source volume if needed).

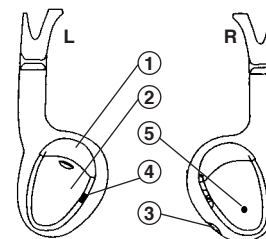

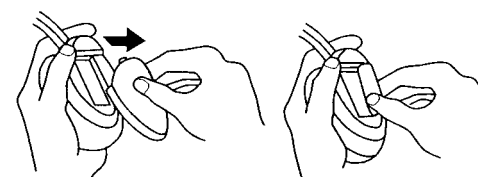

WARNING

Failure to heed the following instructions can result in serious injury or death.

THE DRIVER MUST NOT USE HEADPHONES WHILE DRIVING.

This headphone system is designed for use by the vehicle's passengers only. Use of headphones while driving can inhibit the driver's ability to hear emergency vehicles and other warnings. This can result in an accident causing serious injuries or death.

VIDEO PRODUCTS MUST BE INSTALLED SO THAT THE DRIVER CANNOT WATCH TV/VIDEO UNLESS THE VEHICLE IS PARKED

DO NOT INSTALL THE MONITOR NEAR THE PASSENGER SEAT AIR BAG.

If the unit is not installed correctly the air bag may not function correctly and when triggered the air bag may cause the monitor to spring upwards causing an accident and injuries.

DO NOT LEAVE THE HEADPHONES WHERE IT CAN BE EXPOSED TO EXTREMELY HIGH TEMPERATURES (SUCH AS DIRECT SUNLIGHT) Lengthy exposure to extremely high temperatures, can cause the plastic to soften and possibly deform.

HALT USE IMMEDIATELY IF A PROBLEM APPEARS. Failure to do so may cause personal injury or damage to the product. Return it to your authorized Alpine dealer or the nearest Alpine Service Center for repairing.

ALPINE ELECTRONICS OF AMERICA, INC. AND ALPINE OF CANADA INC. ("Alpine"), are dedicated to quality craftsmanship and are pleased to offer this Warranty. We suggest that you read it thoroughly. Should you have any questions, please contact your Dealer or Alpine at one of the telephone numbers listed below.

PRODUCTS COVERED:

This Warranty covers Car Audio/Visual Products and Related Accessories ("the product"). Products purchased the Canada are covered only in the Canada. Products purchased in the U.S.A. are covered only in the U.S.A.

LENGTH OF WARRANTY:

This Warranty is in effect for one year from the date of the first consumer purchase.

LIFETIME TAPE HEAD WARRANTY:

All Alpine Car Audio analog tape heads excluding Video tape heads are warranted for life against manufacturing defects causing failure.

WHO IS COVERED:

This Warranty only covers the original purchaser of the product, who must reside in the United States, Puerto Rico or Canada.

WHAT IS COVERED:

This Warranty covers defects in materials or workmanship (parts and labor) in the product.

WHAT IS NOT COVERED:

This Warranty does not cover the following:

- 1 Damage occurring during shipment of the product to Alpine for repair (claims must be presented to the carrier).
- 2 Damage caused by accident, abuse, negligence, misuse, improper connections, improper operation or failure to follow instructions contained in the Owner's manual.
- 3 Damage caused by act of God, including without limitation, earthquake, fire, flood, storms or other acts of nature.
- 4 Any cost or expense related to the removal or reinstallation of the product.
- 5 Service performed by an unauthorized person, company or association.

6 Any product which has the serial number defaced, altered or removed.

7 Any product which has been adjusted, altered or modified without Alpine's consent.

8 Any product not distributed by Alpine within the United States, Puerto Rico or Canada.

9 Any product not purchased from an Authorized Alpine Dealer.

10 Any product that has been determined to contain an excessive amount of dust or dirt and any product that contains other contaminants including liquid or foreign objects.

HOW TO OBTAIN WARRANTY SERVICE:

- 1 You are responsible for delivery of the product to an Authorized Alpine Service Center or Alpine for repair and for payment of any initial shipping charges. Alpine will, at its option, repair or replace the product with a new or reconditioned product without charge. If the repairs are covered by the warranty, and if the product was shipped to an Authorized Alpine Service Center or Alpine, Alpine will pay the return shipping charges.
- 2 You should provide a detailed description of the problem(s) for which service is required.
- 3 You must supply proof of your purchase of the product
- 4 You must package the product securely to avoid damage during shipment.

HOW WE LIMIT IMPLIED WARRANTIES:

ANY IMPLIED WARRANTIES INCLUDING FITNESS FOR USE AND MERCHANTABILITY ARE LIMITED IN DURATION TO THE PERIOD OF THE EXPRESS WARRANTY SET FORTH ABOVE AND NO PERSON IS AUTHORIZED TO ASSUME FOR ALPINE ANY OTHER LIABILITY IN CONNECTION WITH THE SALE OF THE PRODUCT.

HOW WE EXCLUDE CERTAIN DAMAGES:

ALPINE EXPRESSLY DISCLAIMS LIABILITY FOR INCIDENTAL AND CONSEQUENTIAL DAMAGES CAUSED BY THE PRODUCT. THE TERM "INCIDENTAL DAMAGES" REFERS TO EXPENSES OF TRANSPORTING THE PRODUCT TO THE ALPINE SERVICE CENTER,

LOSS OF THE ORIGINAL PURCHASER'S TIME, LOSS OF THE USE OF THE PRODUCT, BUS FARES, CAR RENTALS OR OTHERS COSTS RELATING TO THE CARE AND CUSTODY OF THE PRODUCT. THE TERM "CONSEQUENTIAL DAMAGES" REFERS TO THE COST OF REPAIRING OR REPLACING OTHER PROPERTY WHICH IS DAMAGED WHEN THIS PRODUCT DOES NOT WORK PROPERLY.
